MARKET INSIGHT

JULY 22: Benchmark indices bounced and ended with over a percent gain on the back of positive global cues.

At close, the Sensex was up 638.70 points or 1.22% at 52,837.21, and the Nifty was up 191.90 points or 1.23% at 15,824. About 2131 shares have advanced, 1054 shares declined, and 128 shares are unchanged.

JSW Steel, Tech Mahindra, Bajaj Finance, Bharti Airtel and Bajaj Finserv were the top gainers on the Nifty. Top gainers included HUL, Asian Paints, Bajaj Auto, Cipla and Britannia. Except FMCG, all other sectoral indices ended in the green. BSE midcap and smallcap indices rose 1.5 percent each.

MARKET OUTLOOK- CAUTIOUSLY OPTIMISTIC



Quantitative: The fall in Covid cases and the prediction of normal monsoon are likely to improve consumer sentiment. The global market put aside worries of inflation in the US markets as the Fed officials eased concerns about an early rate hike but will look to the minutes of the Fed's April meeting for further cues. In anticipation of a rapid fall in Covid cases, the implication of corporate results and favourable Asian markets, the Indian market made a strong comeback after the three months of muted performance.

Technically, the Nifty has given a Falling Channel breakout and sustained above the prior resistance levels on the daily chart that suggests bullish strength for the upcoming sessions.

The index has also taken good support at 100-DMA and settled above Ichimoku Cloud formation, which indicates a continued upside move for the long term. The Stochastic oscillator and MACD also suggest a positive crossover on the daily time frame. At present, the Nifty is holding support at 15250-200, while an upside resistance seems to be at 16080-16100.
